Dedication and Personal Sacrifices

2009 Annual Letter from the Executive Director



Dear Friends:

The 2009 calendar year, like 2008, was a year of "belt-tightening." I'm very proud of our staff that through their dedication and, in some cases, personal sacrifices, helped to bring about a positive bottom line in our budget. Due to massive state budget deficits, Rhode Island once again cut Medicaid revenues in the area of long term care.

In response to these decreased revenues, Saint Antoine undertook cost saving measures to improve our bottom line:

- Refinancing of Saint Antoine Residence's mortgage debt;
- Restructuring our payer mix;
- United Way grant-funded CNA training program resulting in improved CNA staffing;
- Cutting down in overtime and nursing pool usage, and
- Marketing efforts at The Villa resulting in an improved census.

Cost savings helped to create a positive bottom line not only to "cushion" ourselves against any future cuts but also to fund a much-needed entrance road repaving and main kitchen renovation. Moreover, we are positioned to fund staff raises, which were deferred for one year, as well as any other needed renovation projects.

Medicaid cuts in fiscal year 2010 are predicted to continue, as well as the awaited implementation of a state acuity-based reimbursement system whose total revenue effect is still not clearly known. The community is deeply committed to watching costs and improving revenues in order to strengthen our programs and services despite continued cuts.

We are very proud to share some shining examples of staff dedication during a difficult economic 2009 year:

- The personal fortitude of both Joyce Corsi, Director of Nursing Services, and Laurie-Ann Oliveria, Director of Social Services, as they conducted their Annual Holiday Drive for clothing, toys, food, and other gifts for residents and staff members and their families in need.
- The hard work of the teamHEALTH staff, who over the past three years of the Certified Nursing Assistant Training and Career Laddering program have trained, licensed and employed 165 under-employed, and under skilled individuals with an additional 45 people having graduated or in school to become Certified Medication Technicians, Licensed Practical Nurses, and Registered Nurses. The successes of this program brought a renewed and heightened grant from the United Way (\$600,000 over three years) for TEAMhealth2 which calls for an enhanced job training and career laddering program with an array of funding and program partners.
- Cheryl Gomes, Villa Director of Wellness, receipt of the 2009 "Service above Self" Award, established to honor Emeritus Executive Director Mary Ann Altrui. Cheryl was given the award because she exemplifies the precepts of the award, namely exceptional service to residents and colleagues; role model for others; discharges duties with a cheerful heart, giving soul, and service above self.

We certainly have a deeply dedicated staff. I'm not only very proud of them but I'm also tremendously thankful for their hard work, personal sacrifices, and loving kindness as they live our mission of "providing excellent care by compassionate professionals."
